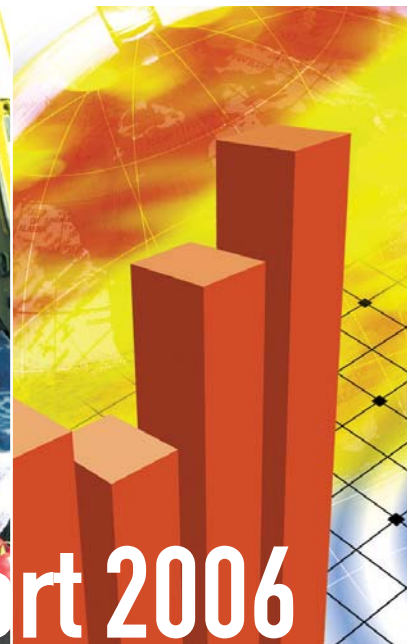

About the report

The statistical part of the ADC report deals in detail with the whole of Austria's Official Development Assistance (ODA). It is intended as a reference source, providing a complete review of the origin, composition, volume and use of Austrian ODA.

Based on the definitions and directives of the OECD Development Assistance Committee (DAC) on reporting Official Development Assistance, these statistics are primarily aimed at providing a basis for international comparison to ascertain how far agreed goals have been met.

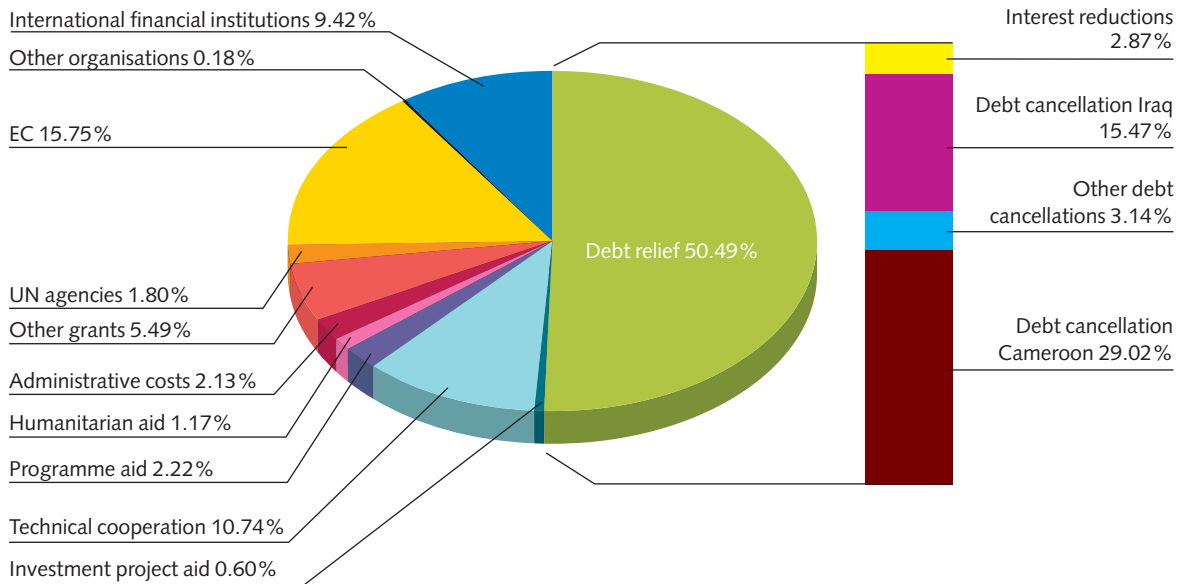
The report proceeds from a general breakdown of the two main components, multilateral ODA and bilateral ODA, to a second, more specific part dealing with special aspects in the period under review. Section III.1 devotes particular attention to the bilateral programme of Austrian Development Cooperation and Cooperation with Eastern Europe (ADC) implemented by the Austrian Development Agency (ADA).

Part I of the ADC report looks at the geographical priorities. ADC concentrates on certain regions and priority countries for more efficient resource allocation. Complementarity and coherence with other international donors play a growing role here.

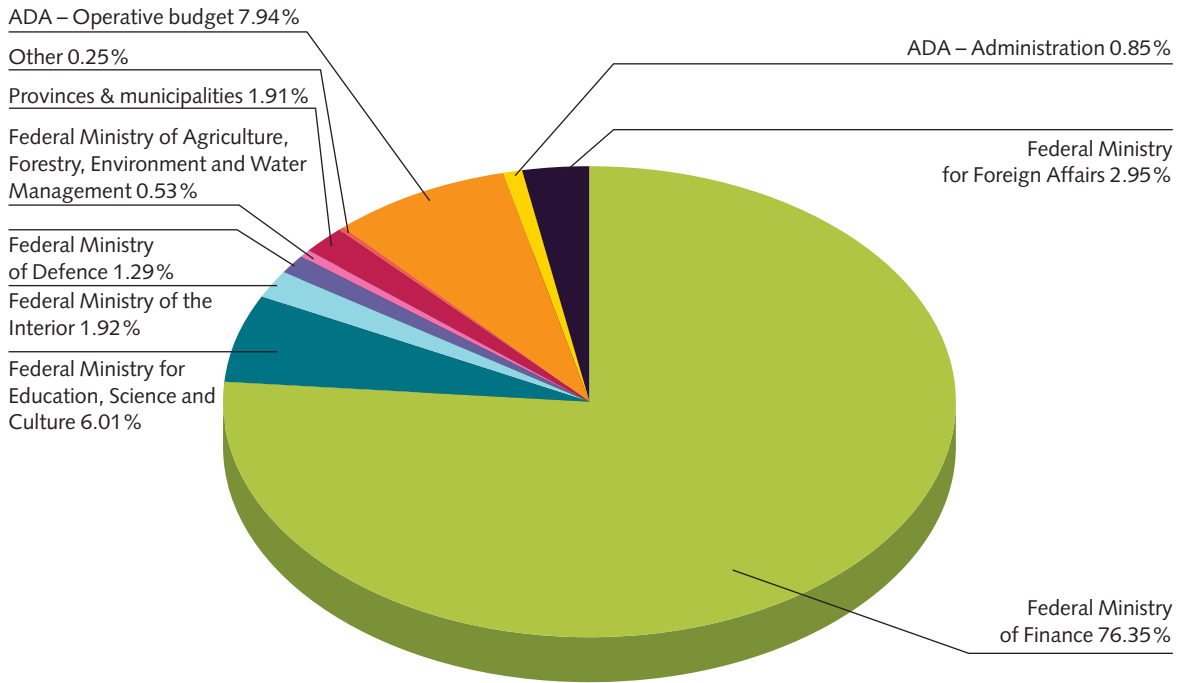
